On **February 4th & 5th**, our Shaw's / Star Market distribution centers will shut down to transition off Supervalu and onto Albertsons Companies 'In-House' ¹ systems; Warehousing, Purchasing, and Invoicing systems will change. If your company ships into these warehouses facilities (see addresses below), you WILL need to make updates within your EDI, Order Management, Transportation, and Invoicing system(s).

Key Conversion Updates & Dates:

Warehouse Deliveries <u>received</u> after **February 5**th will be paid by Albertsons National Accounting Services Center in Phoenix AZ. Part of the system conversion will be to set up your company, authorize valid items, and copy over any outstanding purchase orders. If data is incorrect today, please contact your Shaw's Sales team for correct billing addresses or item information codes.

- Purchase orders will start transmitting February 6th using Albertson's EDI IDs
